## September performance up by 0.1%

New private equity direct investment Zabka Polska

In September, Partners Group Generations Fund I increased by 0.1% and closed with an NAV per share of GBP 1.351. Similar to the previous month, the reporting period was mainly characterized by its investment activity.

In fact, Partners Group completed the acquisition of a stake in Zabka Polska, the leading Polish chain of convenience stores. Founded in 1998, Zabka currently operates a network of more than 5'600 stores in Poland. Partners Group believes the company represents a compelling opportunity to gain exposure to a category leader in the fast-growing Polish modern convenience chain segment with a highly-defensible market position and a sustained and robust growth profile. In addition, Partners Group was attracted by Zabka's outstanding financial performance, its asset-light scalable business model, and its experienced management team. Looking ahead, the management plans to further expand Zabka's store network across Poland. This Fund might restrict outflows in the future.




