#### NAV per share flat for January

- Private real estate investment in Berlin Office Portfolio
- Private equity direct transaction Stratford School Holdings

During the reporting period, Partners Group Generations Fund I's NAV per share remained virtually unchanged, with private equity direct and secondary investments as positive contributors, whereas liquid private markets slightly contracted. With respect to investments, the Fund closed several transactions across three of the four private markets strategies.

On the real estate side, Partners Group completed an acquisition of a Berlin Office Portfolio, which was a vacant office building in a commercial and residential area of the German capital, in an off-market transaction. The property currently comprises approximately 13'800 sqm lettable area including office space and storage space, in addition to 40 outside car parking spaces. Partners Group believes the acquisition is an attractive investment due to its affordable and accessible location in Berlin as well as the city's growing attractiveness as a commercial hub. During 2016, Berlin saw record office take up, with vacancy rates and prime rental rates reaching record lows and highs, respectively. Value-add initiatives for the property include refurbishing the inside of the building and developing a new 3'000 sqm extension, both of which will not involve any structural modifications to the existing building.

The larger of the two private equity direct transactions was Stratford School Holdings, a California-based private school operator, specializing in early childhood to eighth grade education. Founded in 1999, the company generates an EBITDA (12-months rolling) of around USD 34 million. Stratford's curriculum and teaching practices have received high recognition from leading institutions such as the White House and the US Department of Education. Each year, over 90% of graduates are admitted into top choice private high schools or are placed into advanced placement classes in public high schools. Partners Group believes that the company is an attractive investment opportunity given its strong branding and high cash flow visibility. Going forward, Stratford will focus on expanding its operations in South California, entering the adjacent market for high school education and enhancing its course offerings.

In addition, the Fund provided debt financing to Prometric in support of Baring Private Equity Asia's acquisition of the company. Established in 1990, Prometric is an educational support solutions provider with services comprising test delivery, analysis and development. The company delivers an average of seven million exams annually, including the Certified Public Accountant and United States Medical Licensing Examination. Partners Group was attracted to the transaction due to the company's leading position and a loyal customer base with stable revenues.




#### Exposure by regional focus




# Exposure by asset class
