March performance up by 0.8%

 Main performance contributors: Private equity direct investments CPA Global and United States Infrastructure Corporation


In March, Partners Group Generations Fund I increased by 0.8% and closed with an NAV per share of GBP 1.259. Similar to last month, the positive NAV development predominantly stemmed from the portfolio's private equity direct investments. Among others, CPA Global and United States Infrastructure Corporation ("USIC") were the two main contributors this month. CPA Global is a UK-based legal outsourcing company providing general legal and intellectual property support services. While CPA Global offers a variety of services such as document review, contract management, renewals and data management and others, the company is successfully assisting firms and legal departments throughout the litigation and intellectual property lifecycle. In light of the recent merger announcement with IPAN Group in January 2019, the company will be able to gain immediate presence in the German market, which will help drive its global growth strategy. The merger is also expected to provide further cost synergy potentials and upside value creation opportunities for the company.

Furthermore, USIC, the leading provider of infrastructure locating services, has benefitted from an increase in value after publishing the annual results. Since Partners Group's acquisition in November 2017, the company has grown organically in end markets. Further, USIC has exited some unprofitable contracts, which negatively impacted top-line growth. The company, together with Partners Group, is working on improving its productivity with IT solutions and tools, and increasing safety through effective monitoring.


