April performance up by 2.7%


 Main performance contributors: Private equity direct investment GlobalLogic and liquid private markets strategies

In April, Partners Group Generations Fund I increased by 2.7% and closed with an NAV per share of GBP 1.293. Once again, having a broadly diversified portfolio across different asset classes showed fruitful results. Similar to previous months, the portfolio's private equity direct investments had a significant impact on the positive NAV development. Among others, GlobalLogic, the largest private markets direct investments of the Fund's portfolio, contributed positively to this month's performance. The global provider of software product engineering services reported a robust financial performance with double-digit growth in both its revenue and EBITDA for the twelve months ended 30 April 2019. The increase in revenue was primarily due to sustained demand from existing clients and a number of new contract wins while EBITDA growth was driven by an improvement in gross margin and higher utilization. In addition, lower operating expenses further accentuated the company's earnings.

Furthermore, the positive private markets portfolio was complemented by the performance of the Fund's liquid private markets strategies. Especially, infrastructure companies continued its rally after what was a very remarkable first quarter in 2019. For example, Transcanada was one of the strongest listed companies in the portfolio this month. The North American pipeline operator announced the commencement of a binding open season for one of its key pipelines, indicating strong uptake demand. Additionally, President Trump issued a new presidential permit for Transcanada to build the Keystone XL pipeline on the US-Canadian border.


