In September, Partners Group Generations Fund I continued to perform positively and increased by 0.7%, closing with a NAV per share of GBP 1.350. The reporting period was mainly characterized by its investment activity. In one such example, Partners Group acquired a major equity stake in Rovensa, a leading provider of specialty crop nutrition, biocontrol and crop protection products, in a transaction which valued the company at an enterprise value of around EUR 1.1 billion. Founded in 1926 and headquartered in Portugal, the company has approximately 1'440 employees and works with over 1'000 customers in more than 80 countries. Rovensa is considered an attractive investment that is especially pertinent in the current environment. The company operates in the agricultural sub-sector, which has a low correlation to GDP and has demonstrated its resilience during the COVID-19 outbreak. Food production has been mostly uninterrupted during the pandemic given the sustained demand for food, stability of food prices and the desire of governments to ensure a robust food supply chain. As a proponent of well-balanced agriculture, Rovensa's products and philosophy aims to make a positive contribution to the environment and to combat climate change. Rovensa is a contributor to the UN Sustainable Development Goal 2 and especially to target 2.4, which seeks to ensure sustainable food production systems and implement resilient agricultural practices that increase productivity while improving the overall ecosystem quality. Following the acquisition, Partners Group will work closely with Rovensa to continue developing its biological solutions portfolio and to position the business as a clear global leader, while focusing on a variety of strategic topics, from sales efficiency to product development.

Additionally, the Fund made a follow-on investment in Bright Health. Headquartered in Minneapolis, Bright Health began operating in 2016 with the mission of providing a better healthcare experience at a lower cost. The company leverages its integrated technology platform to provide health insurance coverage to over 200'000 members, as well as deliver virtual and direct clinical care services to over 120'000 patients. The capital raised via the company's Series E funding will be used by Bright Health to accelerate the company's new market growth, with plans in 2021 of expanding to new markets within Florida, California, North Carolina and Illinois, and adding employer-based plans to its offering.

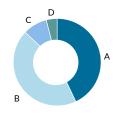

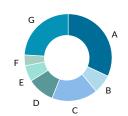
